#### 1.0 Call to Order

Robert Wolff called the special board meeting via teleconference to order at 9:00 a.m. Roll was taken and a quorum was not initially established. A fifth director called in after about six minutes, which established a quorum.

#### 2.0 Review and Approve Agenda

There was consensus to approve the agenda as noticed.

#### 3.0 Questions and Comments from Audience

Elaine Chick, Water Information Program, updated the board on cancellation of SWCD's Annual Children's Water Festival. Roundtable video production is on hold, as the videographer cannot shoot during the stay-at-home order.

#### 4.0 Role of SWCD's Colorado River Committee

Frank Kugel recommended that Colorado River management and policy issues be address by the board as a whole and that the Colorado River Board Committee address specific tasks as assigned by the board, but not meet regularly. Because a quorum was not present at the time of this agenda topic, no guidance was provided on this item.

## 5.0 Comments re. Reclamation's 7d Review of the 2007 Interim Guidelines (time: 00:06:00)

JR Ford joined the call, which established a quorum of board members. Frank Kugel plans to prepare draft SWCD comments on the scope of the U.S. Bureau of Reclamation's 7d Review of the 2007 Colorado River Interim Guidelines for Lower Basin Shortages and Coordinated Operations for Lake Powell and Lake Mead (2007 Interim Guidelines). Frank will provide draft comments for the SWCD board's review at the April 29th teleconference. A board member suggested that, outside of the 7d Review, it would be helpful to know what Lake Powell storage

would have been without the 2007 Interim Guidelines and recommended partnering with the River District to estimate that amount.

# 6.0 Rio Grande Water Conservation District's SWSP Application pursuant to C.R.S. § 37-92-308(5) for the 2020/2021 Water Year (time: 00:10:00

Frank Kugel summarized the Substitute Water Supply Plan (SWSP) application recently filed by the Rio Grande Water Conservation District. Beth Van Vurst and Frank expressed concerns regarding the application, and potential change of use of water originating from the Williams Creek-Squaw Pass and Pine River-Weminuche Pass transmountain diversions that might result in additional water being exported from Division 7 to Division 3. Staff and legal counsel will review the application in detail for further discussion at the SWCD's board's April 29<sup>th</sup> teleconference. Comments on the SWSP are due on May 7<sup>th</sup>.

## 7.0 Update on SWCD Draft Strategic Plan
